### REPORT OF THE PUBLIC WATER TAP IN THE TOWN OF ALBAN

### **SUBJECT**

To provide information to Council in regards with the public water tap at the Alban Community Complex and Fire Hall/ACC.

### BACKGROUND

On March 5<sup>th</sup>, Robert Martin, Facilities Manager for the Municipality of French River reported issues with our Small Drinking Water System for the Alban Community Centre. The report, presented to the Finance and Administration Committee, informed Council about a Sudbury and district Health Unit recommendation to install and UV Water Filtration System at the Alban Community Hall and the Fire Hall. The installation of the work was completed at the end of May beginning of June. During the time of the installation we had to close the public water tap installed in order to allow the work to be completed.

The source of the water at the Alban Community Centre (ACC) is a well. The Municipality of French River does not have a municipal water distribution system.

Following the installation of the UV Water Filtration System, the administration sought counsel from our insurance providers in order to evaluate the risk of re-opening the tap and possible liability that this would put the municipal corporation at risk. What the administration was concerned about was the following:

- Is there increase reporting if we do open the tap for public consumption;
- Should there be a fault to the system, who would be responsible;
- Should someone use the tap with a contaminated container, what would be the liability for the municipal corporation?

On July 18, 2014, Wendy Plante from Rivet Insurance confirmed that with discussion with BFL that there would be no more liability to the municipal corporation for providing a water source than there is now.

On July 24<sup>th</sup> 2014, the Municipality of French River received a directive from the Sudbury and District Health Unit (SDWS # 8610B9C58) by Public Health Inspector Travis DeRocchis that the municipality had properly installed the water filtration device. Inspector DeRocchis also completed a risk assessment of the small drinking water system and noted that at the time of his inspection he believes that the risk category for the ACC and Fire Hall/Library is to be a Low Risk.

### **DISCUSSION**

This service has been in operations for many years. It was originally created to assist the tourist in the area. The municipality encourage most people to proceed with the installation of their own well. Over the years, some permanent residents have depended on the system for public water.

The installation of the system will mean that the municipality will need to test at the same frequency but from both the ACC and the Fire Hall/Library. Furthermore, depending on the use, the maintenance of the UV Filtration System will incurred increase cost to the municipality.

The Municipality of French River has made tourism one of its economic targets for the year. Closing the water tap in the Town of Alban may cause hardship on an industry we are striving to re-energize. Also since there is no additional liability to the municipal corporation, the administration is comfortable that the proper safeguards are put in place to ensure minimal risk to the corporation.

### FINANCIAL CONSIDERATIONS

With the project not creating more liability to the Corporation we do not foresee an increase in our insurance premiums upon our renewals.

However there will be some increase costs to the operations related to the water tap in Alban such as:

- Although our testing frequency does not change, we will be testing both the water coming from the ACC and the Fire Hall/Library. This cost is estimated at an extra \$100.00 per year.
- Depending on water consumption this mean the system may need increase maintenance and will necessitate more sand.
- A sign will have to be erected indicated the times and sates of operations and that we the users are using the system at their own risks.

### **STRATEGIC PLAN**

Provide beautiful places for the community to gather. Provide personalized and efficient customer service.

### **COMMUNICATION PLAN**

Signage will need to be erected to inform citizens clearly about the dates of operations and that the consumption of the water is to be at their own risks.

Furthermore, it is recommended to Council that we adopt similar messaging for Facebook, twitter and our municipal website.

It is also recommended that following Council's decision that some messaging be prepared to inform users about the decision of Council.

### **RECOMMENDATION**

It is the opinion of the administration that the Municipal Corporation would not take additional liability by re-opening the water tap in Alban and therefore that the service should be continued.

### 2. Disclosure of Pecuniary Interest

### 3. Presentation by the French River Multi-Use Trail Association

Mr. Paul Sharp made a presentation of the activities, accomplishments, challenges and issues of the French River Multi-Use Trail Association.

The group wanted to confirm that they have never and will not restrict access to the trail to local users and that there are no interest or intention for a boat launch on Lac Clair. However, they would appreciate local users to purchase passes to show support and partnership. Meetings have been held with the Forestry Management division of the Ministry of Natural Resources (MNR) and a logging company; provisions were established between all parties to ensure logging rights in that area. The MNR has also showed interest in participating in an interactive trail for logging roads and their rehabilitation.

Councillor Larry Bouffard arrived at 10:45 am.

The Mayor commented that numerous concerns were brought up by local residents relating to the trail and suggested that a meeting be held to answer questions and concerns.

The group is applying to the Federal Grant Program for an amount of \$28,000; they must match the funds 50/50 minimum.

The French River Multi-Use Trail Association requested a letter of support, administrative support (Economic Development Manager time) and a loan of \$20,000 to be repaid in 10 years. The purpose of the short notice request for a special meeting was because the grant application is due within a week.

Council discussed the impact on the budget if a loan was provided to the group and the option of the Municipality helping them by guaranteeing their loan (co-sign) at the Caisse Populaire.

The CAO commented that the Waste Management Collection and Disposal project has been examined in-depth by the Environmental Advisory Committee and will be continued to be analysed by Municipal Staff in order to enable Council to choose the best option possible for the residents. The RFP for curbside services would be released at the beginning of August with a deadline of October 31<sup>st</sup>, to give ample time to suppliers to evaluate the Municipality's current system and future waste collection needs and submit a thorough proposal. The results of the RFP will provide pricing and information that is required to evaluate the curbside option to compare to the current system or other possible options. A public consultation plan will be developed to be able to reach as much residents as possible since this is a project that affects everyone. A recommendation to Council is most likely expected in 2015.

### BY-LAW 2014-32

### BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF FRENCH RIVER AT A MEETING HELD THIS 27<sup>th</sup> DAY OF AUGUST 2014

**WHEREAS** pursuant to Section 5(1) of the Municipal Act, 2001, S.O. 2001, c.25 as amended to October 22, 2008, the powers of a municipality shall be exercised by its Council;

**AND WHEREAS** pursuant to Section 5(3) of the Municipal Act, 2001, S.O. 2001, c.25 as amended to October 22, 2008, a Municipal power, including a municipality's capacity, rights, powers and privileges under Section 9 shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** it is deemed expedient that proceedings of the Council of the Corporation of the Municipality of French River as herein set forth be confirmed and adopted by by-law;

# NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF FRENCH RIVER ENACTS AS FOLLOWS:

- 1. The actions of the Council of the Corporation of the Municipality of French River at the meeting held on this 27<sup>th</sup> day of August, 2014 in respect of each motion and resolution passed and other action taken by the Council of the Corporation of the Municipality of French River at this meeting is hereby adopted and confirmed as if all such proceedings were expressly embodied in this by-law.
- 2. The Mayor and proper officials of the Corporation of the Municipality of French River are hereby authorized and directed to do all things necessary to give effect to the actions of the Council of the Corporation of the Municipality of French River referred to in the preceding section hereof.
- **3.** The Mayor and Clerk are authorized and directed to execute all documents necessary in that behalf and to affix the Seal of the Corporation of the Municipality of French River.
- 4. Section 1 does not apply to any action or matter that is required by law to be done by resolution.
- 5. Section 1 does not apply to any matter to which Ontario Municipal Board approval is required until such approval is obtained but Section 2 applies for the purpose of obtaining such approval.
- 6. This by-law shall come into force and take effect on the day it is passed.
